

A17.1- 2016 Code Update with ANSI A117.1 2009/2017

Date: Wednesday, May 27th, 2020 Time: 10:00am-3:30pm (Central Standard Time) Cost: \$150–Members, \$180–Non-members

The training course is set up to highlight the A17.1 2016 Elevator escalator safety code. We will review many of the more relevant changes from the 2016 code that affect your daily process of maintenance and inspection. Followed by a complete review of ANSI A117.1-2009 Standard for accessible use. Our focus in this class will be passenger elevators and the relevant requirements set in motion by A117.1. We will also cover the relevant updates to the 2017 version. The intent of this core course is to familiarize the attendees with the 2016 A17.1 code and review the requirement in the accessibility code A117.1.
