1) 2018 NFPA 70-2017 Code update: This is a code update class of the last two releases of NFPA 70. It is intended to prepare for the new released 2017 version and the changes incorporated.

2) 2018 ASME A18.1 Code update This is a code update class of the last two releases of ASME A18.1. It is intended to prepare the class not only the 2013 changes as they exist in the version there AHJ has adopted or soon will adopt. But to also teach the class the new released 2017 version and the changes incorporated into the latest edition. The intention to keep the 2014 in this presentation because many of you are still in that edition and it is helpful to see those changes in sequence to the 2017 changes.

3) Inspection methods; It is expected the attendee have ASME A17.1, ASME A17.2 and QEI-1 available for this class.
