No refunds will be given after this date. You will be allowed to attend a substitute course/exam if you contact the Executive Office ahead of time. No refunds on no-shows.

**EXAM INFORMATION:** The QEI Certification exam is an online, open-book exam consisting of 160 code questions and 6 demographic questions. You will have 8 hours to complete the exam. A half an hour break is required.
